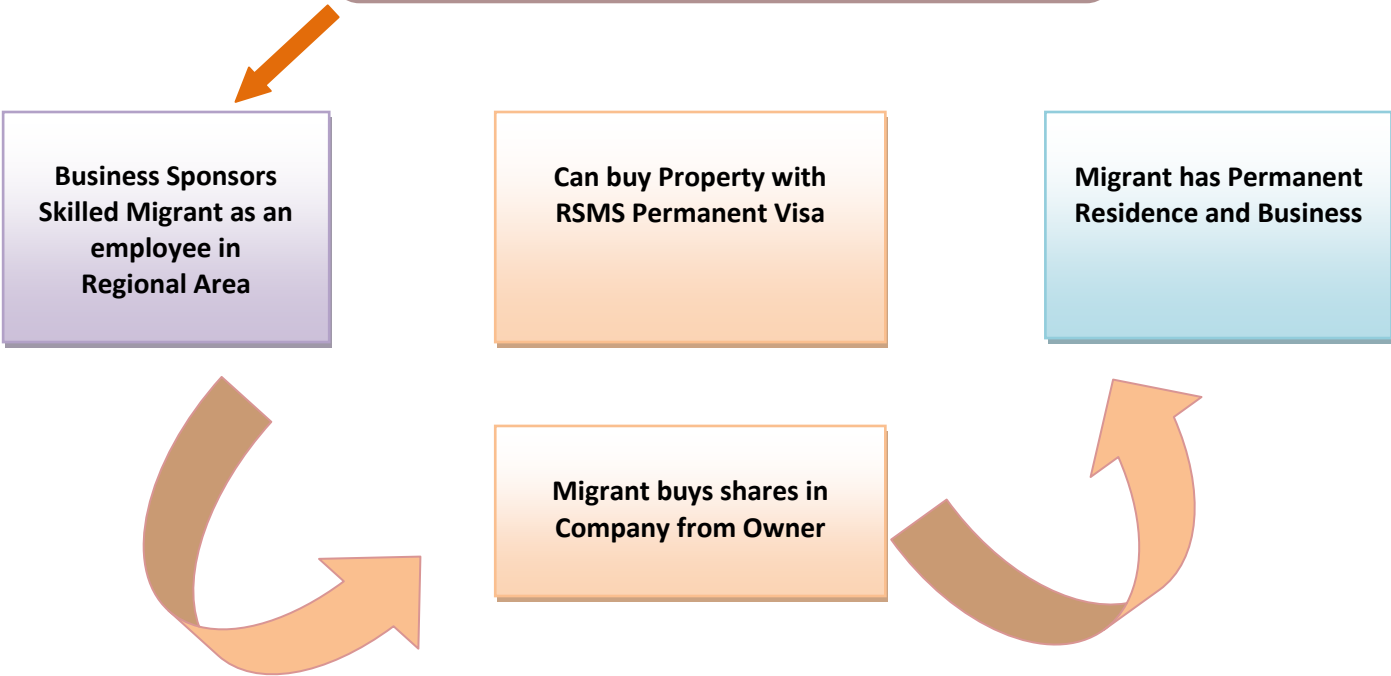


Visa Pathway for Overseas Student to Permanent Residency

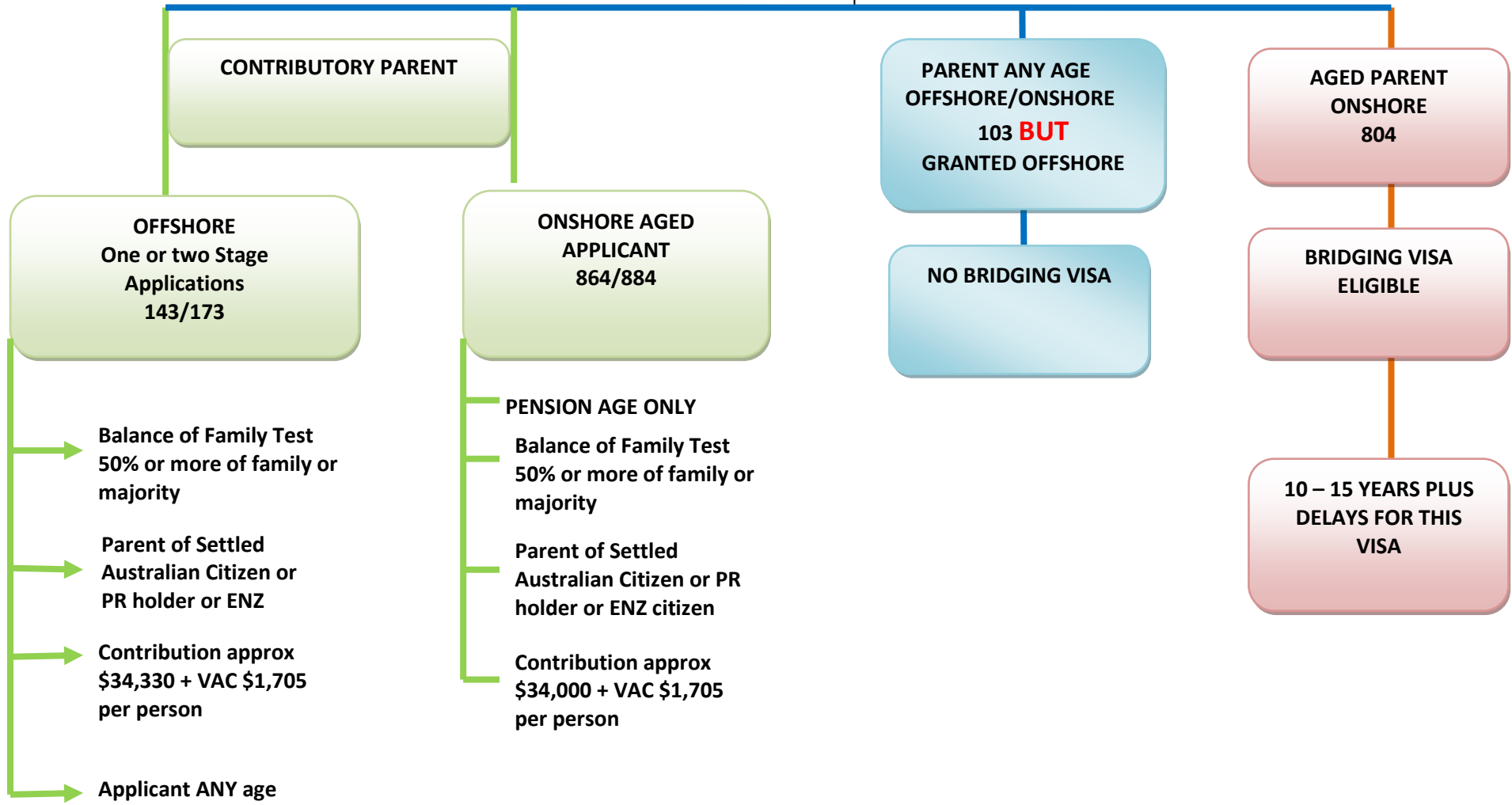
